Responding to the rapidly evolving coronavirus crisis, an increasing number of event cancellations and guidance issued by USEF, USHJA, FEI and the Georgia International Horse Park, GDCTA would like to clarify the current situation regarding our May GADS I & II dressage shows which are scheduled for May 9-10, 2020, just seven weeks away.

At this point in time, we are hoping to proceed as scheduled with our shows. Entries and stall reservations will remain open for both shows and may be secured online at www.eqentries.com where you can create your entry and choose to pay then or save it and email with a CC number or mail it with a check to show manager and entry secretary Caren Caverly. We will hold all checks and not run your credit card till final decision made. If you choose to pay your entry through www.eqentries.com and then the show is cancelled, everything, including office fees, will be refunded to you.

We will continue to monitor the situation and maintain communication with the Georgia International Horse Park, state and local health officials and the relevant equestrian sanctioning bodies. Should we determine that the shows can't be held safely, we will notify all affected parties immediately. Any payments which have already been processed will be fully refunded. In the meantime, we will distribute any updates immediately by email and social media.
